

The Environmental Cost of Cryptocurrency

The Council and Earthjustice are representing Kentuckians for the Commonwealth, Kentucky Solar Energy Society, Mountain Association, Appalachian Citizens' Law Center, and Sierra Club in several cases before the Public Service Commission involving utilities' proposed special contracts with cryptocurrency operations.

Cryptocurrency mining is an under-regulated and extremely energy-intensive process, which threatens the ability of governments across the globe to reduce our dependence on climate-warming fossil fuels. Despite claims of economic development used to justify incentives for these crypto operations, data shows they actually create few jobs. The participation of the Council and our allies in these cases is important both for protecting the public from special contracts with these companies at the expense of ratepayers, and in highlighting the climate impacts of these operations.

In January 2023, KRC is launching a new program, Good Trouble: a Proposal for Coordinated Strategies and Actions in Pursuit of Environmental Health and Justice in Kentucky. Working with allied organizations and supported by technical and legal experts, we are designing a comprehensive environmental permit review training program for citizens and attorneys. This initiative will advance environmental protection, health, and justice across the Commonwealth by combining meaningful citizen participation, science-backed information and analysis, and technical and legal expertise to ensure that Kentucky's environmental decisions are protective of public health and the environment. This project will, for the first time, provide the resources here in Kentucky to empower the public to participate in the permitting processes in the robust and consistent manner envisioned by our nation's environmental laws.



A solar farm for Louisville? A virtual event about making renewable energy a reality Wednesday, January 11, 7-8:30pm | Zoom

A solar power installation in Louisville could go a long way to meeting the city's renewable energy goal. A virtual event in January will explore how that could become a reality.

On January 11 an event titled "REAL Good News" will hold its ninth in a series of quarterly public Zoom meetings aimed at making sure Louisville implements its green energy goals. In 2020 the Metro Council passed a resolution to move the city's operations to 100% clean renewable electricity by 2030. That resolution also sets a goal of 100% clean energy for the entire Louisville community by 2040.
