



#### Fighting for a Cleaner, More Efficient Energy Future

On August 22, 2023, the Kentucky Public Service Commission (PSC) opened a public hearing on Louisville Gas and Electric and Kentucky Utilities' request to retire four coal-fired electric generating units and three natural gas simple cycle combustion turbine units, and to replace them with two new natural gas combined cycle facilities, two solar facilities, one battery storage facility, and four solar power-purchase agreements. LG&E and KU need the PSC's approval to build these new gas plants and must show a need for the new generating capacity and an "absence of wasteful duplication." They are also seeking approval for their proposed demand-side management plan.

This request is also the first test of Kentucky's 2023 Senate Bill 4 ("SB4"), a law advocated by coal interests to attempt to extend the life of coal-fired power plants, which requires utilities to seek approval from the PSC to close fossil-fueled electric generation. KRC and our allies opposed SB4 during the 2023 legislative session, joined by several utility companies who said the bill would damage grid reliability and raise costs by forcing utilities to operate coal plants past their useful lives.

Alongside Earthjustice, KRC represents Metropolitan Housing Coalition, Kentuckians for the Commonwealth, Kentucky Solar Energy Society, and Mountain Association as Joint Intervenors in this case. KRC attorneys Tom FitzGerald and Byron Gary attended the six-day hearing, where the Joint Intervenors advanced a business case for closing these coal-fired plants. They rebutted LG&E and KU's case for building two new greenhouse gasemitting power plants rather than aggressively pursuing energy efficiency, renewables, and other strategies to meet and lower energy demand.

There is also still time to submit a public comment and tell the PSC that Kentucky needs a cleaner and more energy efficient future! Comments can be submitted until October 4.

# KRC and Allies Help Secure a Victory for Kentucky Ratepayers

This week, the PSC denied millions of dollars in electricity discounts offered by utility Kentucky Power to support a proposed massive and energy-intensive cryptocurrency mining operation in Eastern Kentucky, owned by Ebon International. The PSC found that the potential risks to ratepayers outweighed any economic benefits. KRC and Earthjustice

represented Mountain Association, Kentuckians for the Commonwealth, Appalachian Citizens' Law Center, Sierra Club, and KRC as Joint intervenors in the PSC case.

"We are pleased with the decision in this case, and grateful the Commission has decided to take a closer look at the ongoing subsidies provided to these wasteful facilities. We hope the Commission will continue to place consideration on the impacts of its decisions on the average ratepayers already struggling with high electric utility bills."
